pH NEUTRAL

The watery extract of the fibrous support is pH neutral.



ACID FREE

Use of production processes conducted in non-acidic environments, in particular with regard to the phases of paper sizing.



LONG LIFE

Complies with the requirements in the ISO 9706 standard, allowing the paper to be described as 'long life' and guaranteeing its durability, while also certifying that it contains no more than 5 % of wood pulp or semi-chemical pulp, has a pH between 7.5 and 10 in the watery extract and an alkaline reserve of more than 2 %.



ECF

(Elemental Chlorine Free)

The pulp has been bleached using environmentally-friendly processes that guarantee a maximum level of derived organic chlorine compound contents of less than 0.8 kg/ton.



TCF

(Total Chlorine Free)

The pulp has been bleached using environmentally-friendly processes that use no chlorine-based products at all and guarantee a maximum level of derived organic chlorine compound contents of less than 0.2 kg/ton.
